- Fellowships and Training



Request for Proposals: Opioid Crisis Innovation Challenge 2024

Purpose

While much effort, resources, and funding has gone to addressing the nation's opioid and overdose crisis, we continue to be faced with a national crisis of opioid-related addiction and poisoning.

Launched in 2022, FORE's Innovation Program has supported projects that combine strategies from diverse fields and engage multidisciplinary teams to tackle some of the opioid crisis' most intractable problems.

The first cohort of projects focused on reducing stigma through creative ways of educating community members, leaders, and healthcare providers, and on developing novel, cross-sector collaborative methods to generate more timely and actionable data to better guide government responses to and inform the public about the opioid crisis.

FORE now sees an opportunity to further build the Innovation Program by generating new ideas and potential solutions for other significant, challenging problems related to the crisis.

Funding Opportunity: Target Projects

This RFP targets projects which can explore and/or evaluate new "outside-the-box" ideas, bring together approaches from several diverse fields, and engage multi-disciplinary, cross-sector teams to solve some of the crisis' most intractable problems. Focused on three areas:

- 1. Innovative Payment Models. e.g., creation and/or evaluation of payment models for improving access to all aspects of an individual's treatment plan, development of quality measures to assess value of care, and/or analysis of policy issues, such as parity for SUD care or disparities in treatment reimbursement.
- 2. Workforce Development. e.g., programmatic and policy work to expand and sustain the addiction and behavioral health care workforce pipeline, to deploy the current workforce in more strategic and impactful ways, and/or to create new training opportunities for peers.
- **3.** Supporting the Transition from Treatment to Recovery. e.g., development of innovative ways to address barriers facing those transitioning to long-term recovery, for example, recovery housing models



Funding Opportunity: Target Projects

FORE prioritizes work which incorporates a focus on patientcentered solutions and on health equity, as well as reaching diverse high-risk populations. FORE also assesses projects within a framework of meeting one or more of our overarching objectives of supporting:



<u>Award</u>: up to \$300,000/year for up to two years <u>RFP Open</u>: June 14 – August 8, 2024



Funding Opportunity: Eligibility

Generally, FORE will consider grant requests for *specific charitable purposes* from:

- U.S.-based 501(c)(3) public charities and organizations;
- Tax-exempt institutions of higher education (public and private);
- State governments and agencies;
- Local governments and agencies;
- City or township governments; and
- Native American tribal governments.

- Competitive applications will demonstrate clear, immediate needs, as well as the potential to inform short-term improvements as well as longer-term, broader impact, sustainability, and scalability.

- Need/Problem Being Addressed: Briefly describe the immediate unmet need that this proposal seeks to address and how the innovative strategy proposed would address it (maximum 100 words).
- **Project Goal:** Provide a brief summary of the anticipated project goals (maximum 50 words).
- **Strategy and Approach:** Briefly describe the strategy and approach the proposed project will seek to accomplish the Project Goal above. Why is this approach innovative? (maximum 150 words).
- **Expected Outcomes:** Briefly describe the expected outcomes for the project. What impact will this project have on opioid use disorder patients and/or the field (*maximum 100 words*)?
- Organization Information & Support: Briefly describe your organization and its qualifications (as well as potential partnering organizations) for successfully completing the project (maximum 100 words).
